FACTS	
Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	The types of personal information we collect and share depend on the product or service you have with us. This information can include: <ul style="list-style-type: none"> • Social Security Number and Credit Score • Payment History and Mortgage Rates and Payments • Checking Account Information and Employment Information
How?	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Dovenmuehle Mortgage, Inc. chooses to share; and whether you can limit this sharing.

What we do	
How does Dovenmuehle protect my personal information? How does Dovenmuehle collect my personal information?	<p>We collect your personal information, for example, when you:</p> <ul style="list-style-type: none"> • Give us your contact information or provide account information • Give us your income information or provide your mortgage information • Pay us by check <p>We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.</p>
Why can't I limit all sharing?	<p>Federal law gives you the right to limit only:</p> <ul style="list-style-type: none"> • Sharing for affiliates' everyday business purposes- information about your creditworthiness • Affiliates from using your information to market to you • Sharing for nonaffiliates to market to you
What happens when I limit sharing for an account I hold jointly with someone else?	Your choices will apply to everyone on your account

Definitions	
Affiliates	<p>Companies that we own or control, a company that owns or controls us, or a company that is owned and controlled by the same company that owns or controls us. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> • Our affiliates include companies with a Dovenmuehle name; financial companies such as Dovenmuehle Funding, Inc. and Dovenmuehle Mortgage Company, L.P.; and nonfinancial companies such as Dovenmuehle Insurance Agency, Inc.
Nonaffiliates	<p>Companies that are not an affiliate of ours and are not related by common ownership or control.</p> <ul style="list-style-type: none"> • Nonaffiliates we share with can include financial institutions, insurance companies, data processing companies and other entities that help us service your mortgage.
